This agreement is made and entered into this day and month written below between KSG Quarter Horses Inc, Myakka City, Florida ("Stud Manager") and _____
These Parties agree to as follows:

1. Mare owner agrees to breed the mare ("Mare") _____
_____ to IMA DUE GOODER TOO standing at KSG Quarter Horses, Myakka City Florida. Frozen

Semen for the 2010 breeding season will be stored at Emerald Ridge Farm Ontario , Canada.

2. The Stallion Service Fee shall be Zero. Booking/chute fee is \$450.00. Booking/chute fee must be paid prior to shipment of semen. Shipping expenses via Fedex, UPS and/or Counter to Counter still apply.

3. The Stallion service fee shall include enough frozen semen straws needed for one heat cycle for one mare. Should additional straws be needed, then there will be an additional charge of \$175.00 plus shipping expenses.

4. Mare owner hereby agrees to notify Emerald Ridge Farm with the date their veterinarian would like to receive the semen. Mare owner hereby agrees to follow the protocol given by Emerald Ridge Farm and pay all shipping expenses directly to them.

5. Mare owner shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, mare Owner will hold Stallion Owner and Manager harmless.

6. The breeding season for frozen semen begins February 1 2010 and runs through June 30 2010.

7. If mare does not settle in 2010, or if mare loses her foal, stallion owner will honor the stallion service fee on the mare originally booked unless otherwise mutually agreed in writing between mare owner and stallion owner for the following year only. This contract also constitutes a live foal guarantee (live foal is defined as a foal that stands and nurses without assistance)giving mare owner the following year only to again breed the mare originally booked unless mutually agreed upon in writing between stallion owner and mare owner. Mare owner will again be responsible to pay a booking fee/chute fee of \$450.00 plus the cost of shipping. These prices are subject to change in the year 2011. If Mare Owner fails to breed the mare (or substitute mare mutually agreed as stated above) in the following year, then any and all fees paid shall not be refundable; the right to re-breed is thereby cancelled and Stallion Owner is released from any further obligation.

8. This contract shall not be transferable by Mare Owner without prior written consent of Stallion Owner. A breeders certificate will be issued when the mare owner notifies KSG Quarter Horses of the birth of the foal and only after all bills due on the mare have been received. This agreement constitutes the entire agreement between the parties; and amendment to or modification of the terms of this agreement must be in writing.

9. Should it be necessary for Stallion Owner to employ an attorney to enforce any of the terms in this agreement, including collection of monies owed, Mare Owner shall pay all reasonable attorney's fees, costs of suits, and other expenses related to enforcing this agreement.

10. Requirements prior to shipment:

- a. original signed contract
- b. Payment of stallion service fee, booking and chute fees.
- c. Copy of the mare's registration paper, both sides.
